The agistee/s are responsible, if more than one jointly and severally, for payment of the agistment fees (item 4) until the agistment ceases by agreement or upon one party giving the other seven (7) days notice of termination of this agreement. Agistment accounts to be paid 7 days in advance on the day nearest to the bloodstock arriving at PVS Training & Equine Services.
3. The agistees are responsible for full payment of the account notwithstanding the bloodstock may have been removed from PVS Training & Equine Services.
4. Pamela Kingwill is able to accept instructions from the persons referred to in item 2 of the schedule. If more than one person is listed, Pamela Kingwill need only receive authority, information and request from one party and that party’s authority shall be sufficient in all respects of PVS Training & Equine Services.
5. In the event that the agistees change addresses it is their responsibility to notify PVS Training & Equine Services in writing of the change. Pamela Kingwil shall make appropriate attempts to contact the agistees or their nominated emergency contact in the event of any emergency or misadventure by their bloodstock.
6. In the event that the agistees are not contactable and their bloodstock requires treatment or euthanasia the services of an independent veterinarian (Burdenkin Veterinary Services) shall be sought and engaged to carry out the treatment or euthanasia. The cost of the veterinarian’s fees shall be paid by the agistees in full.
7. Agistment of Bloodstock at PVS Training & Equine Services is solely at the risk of the agistee and Pamela Kingwill nor PVS Training & Equine Services or it’s employees or staff shall not and does not accept any liability for damage and or loss that occurs to the bloodstock, the agistees or their nominees or any rider of the bloodstock. Pamela Kingwill shall at all time use every effort to ensure the safety of the bloodstock in a suitable environment in accordance with appropriate equine practices.
8. Pamela Kingwill or a PVS Training Stable rider has agreed to training the horse in Item 3 on a basis set out in Item 4. The horse will be given no less than 4 training sessions per week (average 5 sessions per week). Included in the agistment fees are the inclusions set out in Item 4.

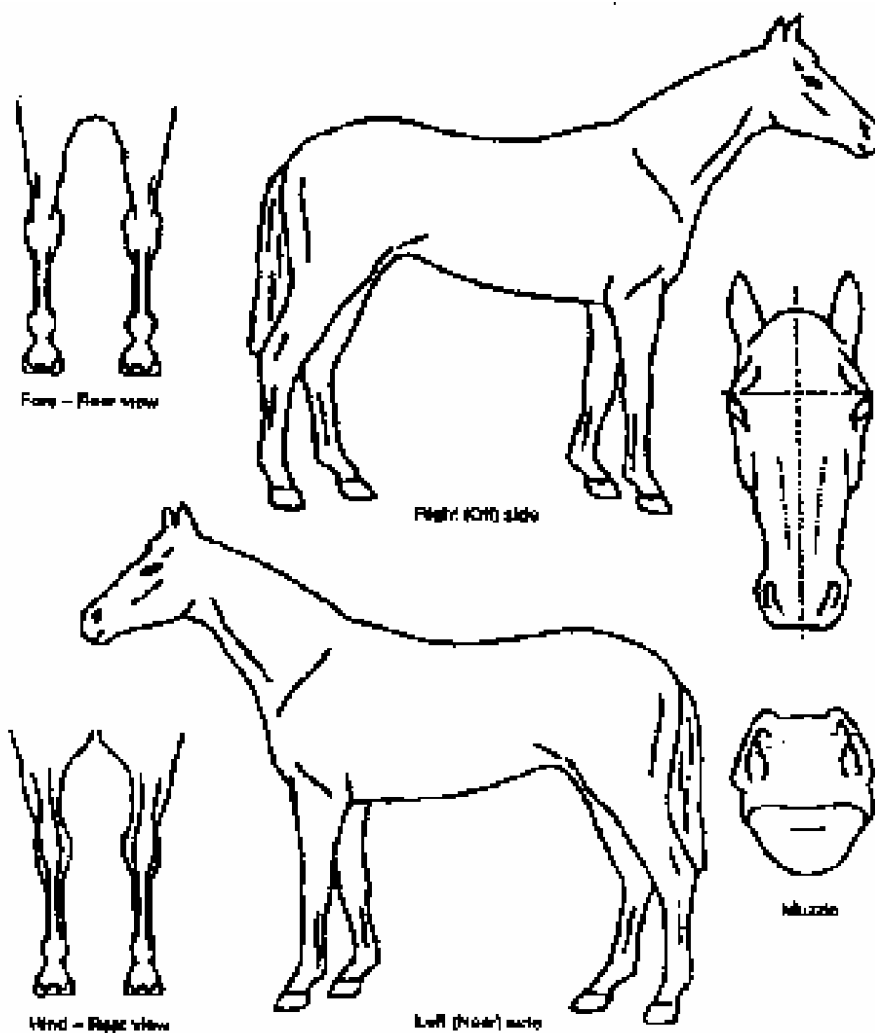
